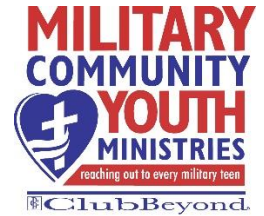


# Steps for Leaving a Legacy Gift to Military Community Youth Ministries (MCYM)



## 1. Insert Military Community Youth Ministries (MCYM) language in your legacy document

Insert the appropriate language within your will, trust, or as a beneficiary designation to assist Military Community Youth Ministries (MCYM) in the future. You can provide flexibility for your future gift or more clearly define what you would like your legacy gift to support.

## 2. Sign a Future Gift Intent form

The Future Gift Intent (FGI) is an internal document that MCYM uses to further confirm your gift intent and how you would like your assets to benefit the ministry in the future. Please contact MCYM's Director of Development, Emily Mahoney, so that we can properly document your future gift to ensure that when the funds come to MCYM your legacy plan will be carried out as you intended. ## Sample Bequest Language

For your convenience, we've provided sample language for making gifts by will or trust to MCYM. You will want to consult your legal and financial advisors if you would like further suggestions about planning your gift. Please also contact Emily Mahoney to continue the conversation about a legacy gift specifically to MCYM.

MCYM is a tax-exempt corporation under subsection 501(c)(3) of the Internal Revenue Service code. All gifts to MCYM are used for the benefit of the ministry. The Federal Identification Number for MCYM is 74-2238462.
